1. Who Is Required to Pay Tuition Fees?

In accordance with Danish legislation, non-EU/EEA/Swiss citizens must pay tuition fee while enrolled at higher education institutions in Denmark.

EU/EEA/Swiss citizens are not required to pay tuition fees to enrol in degree programmes in Denmark. This pursuant Danish legislation.

The following non-EU/EEA citizens will continue to be exempt from paying tuition fees:

- Exchange students studying in Denmark through bilateral agreements between Danish universities and one or more universities abroad.
- Students who have dual citizenship in both an EU country and a non-EU country.
- Students with a permanent Danish residence permit.
- Students with a preliminary Danish residence permit with a view to (in Danish: med henblik på) permanent residency

2. Terms of Payment

The tuition fees are:

Architecture

2021-22 academic year: 6,500 EURO per semester

Design

2021-22 academic year: 6,500 EURO per semester

Craft: Glass and Ceramics

2021-22 academic year: 8,500 EURO per semester

The tuition fee for each semester must be paid in full by the payment deadline, prior to the start of the semester. It is possible to pay the tuition fee in Danish

kroner - if you wish to do so, please contact the Royal Danish Academy's Study Administration.

Separate payments must be made for each semester - it is not possible for students to pay for an entire academic year. The tuition fee does not include accommodation, study trips and materials for projects.

It is not possible to pay in smaller installments during the semester. Note that the tuition fee is subject to change. Any changes will be announced 2 years ahead.

2.1 Payment Deadlines

Applicants Accepted for Admission

Admission will be announced until mid-May. The exact payment deadline will be given with the admission offer. Applicants accepted for admission must pay for the first semester within 10 days of being offered admission. If an applicant fails to pay by the deadline, the application will be rejected.

Students Currently Enrolled

Students who are enrolled at the Royal Danish Academy are required to pay by 15 August for the autumn semester and 15 January for the spring semester. Students who fail to pay will have their enrollment withdrawn.

2.2 Leave of Absence from the Studies

Current students applying for a leave of absence from the studies must submit an application in writing to the Study Administration no later than 1 August for the autumn semester or 1 January for the spring semester to avoid paying tuition fees for that semester.

2.3 Withdrawal from the Studies and Refunds

Students withdrawing from the studies, including students accepted for admission, must confirm their withdrawal in writing to the Study Administration before 1 September for the autumn semester or before 1 February for the spring semester in order to receive a refund of the paid tuition fee.

The tuition fee for the semester cannot be refunded once the semester has started.

All refunds are subject to an administration fee of 200 EURO.

Important! When holding a leave of absence or withdrawing from the studies, you are not registered as "study active". This can have consequences if you have a student residence permit; for example, you may not be allowed to stay in Denmark and will have to apply for a new residence permit. It is important to read

the details of your residence permit and contact the Danish Agency for International Recruitment and Integration (SIRI), who issues the permits. See
